

FACTS**WHAT DOES WISCONSIN WEALTH ADVISORS, LLC DO WITH CUSTOMER INFORMATION?**

Why? Financial companies choose how they share your Customer Information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your Customer Information. Please read this notice carefully to understand what we do.

What? The types of Customer Information we collect, and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Account balances and payment history

How? All financial companies need to share Clients' Customer Information to run their everyday business. In the section below, we list the reasons financial companies can share their Clients' Customer Information, the reasons we choose to share, and whether you can limit this sharing.

Definitions

Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.
Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
Joint marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you.

How do we protect your Customer Information?	<p>We maintain policies and procedures reasonably designed to safeguard customer information, including:</p> <ul style="list-style-type: none"> • Administrative, technical, and physical safeguards to protect against unauthorized access or use; • Proper disposal of customer information when no longer required; <p>Oversight of service providers who may access or maintain customer information.</p>

Why can't you limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> • Sharing for affiliates' everyday business purposes—information about your creditworthiness • Affiliates from using your information to market to you • Sharing for non-affiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p>
What happens when you limit sharing for an account you hold jointly?	<p>Your choices will apply to everyone on your account—unless you tell us otherwise.</p>
Google Analytics	<p>We use Google Analytics on our corporate website. Google Analytics mainly uses first-party cookies, data related to the device/browser, IP address and on-site/app activities to measure and report statistics about user interactions while on our site. Users may disable cookies or delete any individual cookie.</p> <p>Google Analytics also collects Internet Protocol (IP) addresses to provide and protect the security of the service, and to give us a sense of which country, state, or city in the world our users come from (also known as "IP geolocation").</p>
